# **WIF 2025 Photo & Video Contest Overview**

This summary is not the complete rules. Refer to full official rules below for all the details.

1. **3 Different Concurrent Contests:** 1) Team (Photographer & Landowner); 2) Individual Photographer; 3) Videographer. Each contest has separate prize purses.
2. **\$40,000 Combined Prize Purse for Team Photo & Video Contest, \$5,000 for Individual Photo Contest.** WIF will help pair landowners and photographers when desired.
3. **Team Contest** Private Landowners anywhere within the entire state of TEXAS are eligible to participate, any size land. \$500 Entry Fee – Enters you in both Team Contest Video Contest and allow you to accept individual photographers. Prize money for individual photos and team winners is split 50/50 between the landowner and photographer on the team. Team grand prize winners are selected based on the portfolio total of accumulated points for winning images.
4. **Team Contest** Photographers enter by paying \$500 entry fee. Enters you in both Team Photo Contest and Video Contest. Photographers can form a 2-person photographer team for a \$500 team entry fee. Prize money for individual photos and grand prize team winnings are split 50/50 between the landowner and photographer(s) on the team.
5. **Individual Competition (Separate Prize Purse) Photographers:** Entry options from \$100 to \$500 See rules for details. Individual photos can win awards and prize money for photographers. WIF provides a list of available landowners to photographers.
6. **Video Contest:** Entry is included in your team photo contest entry and with specific individual photo contest entries, see full rules. For those that want to do only video they may enter only the video contest. 8 Categories. \$100 video-only entry fee, prize purse of \$2,400. See Attachment A for important details.
7. **DATES of CONTEST:** Feb 21, 12:01am to May 31, 2025, 11:59pm. Photos must be taken on the designated land during the official contest dates (~100 days) in RAW format with a minimum 12MP camera.
8. **Photo Contest – Up to 3 images may be submitted per category, 0 to 3 per category. There are the same 50 categories for the team and individual contests.**
9. **Privacy:** Images that have been entered into the contest MUST be withheld from public showing (particularly social media) until AFTER the Awards Banquet.
10. Photographers work to acquire and submit a portfolio of up to 100 images for judging. Image submissions include the original RAW file, a TIFF file, and a JPG for judging. A JPG copy of submitted portfolio will be supplied to the landowner by the photographer for personal viewing use.
11. All photos must accurately reflect the subject and background as it appeared in the viewfinder. Nothing can be added to an image, and aside from the elimination of dust spots from a dirty sensor and normal cropping. Nothing can be erased or moved away.
12. For the team photographer, the landowner provides free access to the photographer, including overnight, and assists as desired to help win the contest. Individual photographers arrange access with landowner and may pay a lodging/photo fee.

## **SECTION 1A - THE TEAM PHOTO CONTEST**

The 2025 Wildlife In Focus – Texas Conservation Photo and Video Contest (the “Contest”) will pair each photographer with a landowner to form a team (“Team”). Prize winnings will be split equally between the photographer and the landowner. The photographers must shoot exclusively on the landowner’s property as registered and specified in the “Landowner Registration Form”. The dates of the Contest are February 21, 2025, through May 31, 2025 (the “Contest Period”).

### **A1) WHO MAY ENTER (PHOTOGRAPHERS)**

Any photographer over the age of 18, whether a professional or amateur, may enter the Contest. Photographers may work singly or in teams of two.

### **A2) WHO MAY ENTER (LANDOWNERS)**

Any landowner or lessee, meaning the person with legal authority to allow the photographer access for photographic and video capture, as well as the sharing of any prize funds (the “Landowner”), may enter the Contest as long as the land to be used in the Contest is within the state of Texas.

#### **Landowner Responsibility:**

It is the sole responsibility of the Landowner member of any Team to establish guidelines for use and access to the property. Landowners may require Photographers to sign a Release of Liability (ATTACHMENT G). Any complaint concerning a Team member’s conduct during the Contest Period should first be discussed between the members of the Team. If the complaint is not resolved among the Team members, then the complaint may be brought to the attention of the Rules Committee. Should the Rules Committee find that a violation of the contest rules has occurred, the penalty for said violation shall be left to the sole discretion of the Rules Committee and WIF Board.

### **A3) PARTNERSHIP FORMATION**

Photographers and Landowners may have a particular partner in mind with whom to form a Team, Participants may select their own partners and designate each other on the registration form.

A photographer or landowner also may register for the contest without having a partner and request that WIF find a partner for them. WIF will aid in matching Photographers with Landowners, and will provide contact information to both parties. It will be the responsibility of the participants to make their own arrangements once a team partnership has been established. Should a partner not be found, WIF will offer

another participation option or a refund per the refund dates and policies described elsewhere in the rules.

#### **A4) REGISTRATION FEES & Eligibility - TEAM**

A) **PHOTOGRAPHERS:** Any photographer 18 years old and older may register, amateur or professional. Actual participation depends on forming a team with a landowner.

B) \$500 per photographer with a maximum total of 100 images (up to 3 per category, with only 1 image per species except for independent male and female images)

C) \$500 for a team of two photographers, may submit a maximum total of 100 images or video submissions (up to 3 per category). Both photographers' names must be listed on the entry forms.

D) A Photographer or 2 Person Photography Team may only enter the contest once, with a single landowner teammate.

E) A photographer may have an assistant that does not take photos at no additional expense when accompanied by the photographer. Independent access to the land for an assistant must be approved by the landowner team member.

F) **LANDOWNERS:** Any private landowner is eligible to enter. Actual participation depends on forming a team with a photographer. Publicly owned lands are not eligible for this contest. (Other future events may include publicly owned lands)

G) \$500 per Landowner. A landowner may allow a single photographer to access multiple non-contiguous lands owned by the same owner, all of which would be considered the same team entry. **OR**

H) Multiple photographers per landowner. A landowner can team with photographers in the following manners:

1) a contiguous parcel of land - A landowner may team with multiple photographers by paying for each with separate entry fee and by complying with the additional specifications for having designated land boundaries, each with a water feature, for each photographer. A detailed aerial image (like a Google Earth image) of land with boundaries and key access locations for each photographer is required.

2) A landowner that owns multiple parcels of non-contiguous land may have a different photographer on each piece of land by paying a separate entry fee for each team.

3) A landowner may at their choice accept additional photographers that shoot as

individuals rather than as part of a landowner/photographer team without the landowner paying any additional registration fee. In this situation, the landowner would not be eligible for any of the monetary prize winnings for these individual photographer submissions should they win awards. The photographer would be eligible to receive their half of the monetary award for individual category prizes but not for any team awards (grand prizes). For these photographers, the landowner may choose to charge for access, use of blinds, overnight lodging, etc., same as for a photo ranch business operation, or may choose to offer access, etc., for free – it is up to the landowner. The landowner would need to inform these photographers of all fees and access requirements in detail ahead of registration, so they do not think they are shooting as the landowner's team photographer.

## **A4a) REGISTRATION FEES & ELIGIBILITY – INDIVIDUAL PHOTOGRAPHER CONTEST**

### **INDIVIDUAL PHOTOGRAPHER CONTEST**

A) Photographers **may** enter the individual photographer contest and not be the landowner's official team photographer. In this situation, the photographer is shooting as an individual and is eligible for prize money for the individual Contest prizes **which are from a separate prize purse than the team contest**. The individual photographers working independently would also need to learn landowner's access requirements including what fees would need to be paid to access, photograph, lodge overnight, etc., as with any guest business or photo ranch. Entry options are as follows:

B) Individual Photo Entry (non-team member):

Option 1 - \$100 May submit 10 images

Option 2 - \$200 May submit 20 images, also entered into the video contest and may submit videos as per the video contest rules

Option 3 - \$300 May submit 30 images, also entered into the video contest and may submit videos as per the video contest rules

Option 4 - \$400 May submit 50 images, also entered into the video contest and may submit videos as per the video contest rules test rules

Option 5 - \$500 May submit 100 images, also entered into the video contest and may submit videos as per the video contest rules

C) An individual photographer may not enter the team photography contest but will be registered to enter the video contest. An individual photographer may take photos and enter the individual contest at as many registered landowner properties as desired, but a new registration must be paid for each different property and entry.

### **A5) REFUNDS**

Early registration is helpful to facilitate finding a team partner. WIF will assist registrants as needed to find a team partner, however final team determination is up to each registrant. Registration fees paid prior to Nov 1, 2024, will be eligible for a refund until Dec 1, 2024. A \$25 administration fee will be deducted from the refund. After Dec 1, 2024, all entry fees are non-refundable. However, a credit of 50% of entry fees paid will be offered toward other Wildlife in Focus products, event registrations or services. The credit will expire 6 months after it is issued.

### **A6) REGISTRATION DEADLINE**

The registration deadline for all Photographers and Landowners is December 1, 2024. The Registration Form with registration fee must be received by WIF before 5:00 p.m. on December 1, 2024. WIF reserves the right to extend the deadline or deny any fees or forms after this time. Please contact WIF for late registration rules and payment. Photos submitted for judging bearing a date taken before the date of completed registration and full payment will be disqualified.

## **SECTION 2B) Contest Dates and Photography Requirements**

### **B1) SHOOTING PERIOD**

100 Days - Shooting begins on February 21, 2025, at 12:01 AM and ends on May 31, 2025, at 11:59 PM. Entries outside of these dates will not be accepted or considered. All entries must consist of images taken by the Photographers on lands registered in the contest.

### **B2) SETTING CORRECT TIME AND DATE**

Prior to shooting your first photo, verify that your camera is set to the correct date and time. In addition, ensure it is set to other contest specifications for color (Adobe RGB) and format (RAW), etc.

### **B3) PHOTO FORMATS – CAREFULLY READ THIS SECTION**

For the purpose of this section and those that follow in these rules, "RAW" shall refer to RAW



images captured as the generally native digital file for varying brands of camera (Example: Nikon = NEF, Canon = CRW or CR2, etc.) and to DNG files captured by drone-mounted cameras. If you have questions regarding photo formats, please contact the Wildlife in Focus office.

The judges use the RAW files to check compliance with rules of the contest, especially regarding edits and date of the photo. Entries for each image entered will have a RAW file, a TIFF, and a JPG. The TIFF is generated from the RAW file and the JPG is generated from the TIFF.

#### **B4) ALLOWABLE CAMERAS**

Photographers may use any digital camera capable of photographing in RAW format with a minimum twelve (12) megapixel resolution. Mirrorless, drone camera (see below for drone restrictions), DSLR, Mirrorless, Point and Shoot, Phone Camera, etc., are allowed if they can shoot in RAW format and are set to shoot in the RAW format specific to that camera. In camera setting for compressed RAW is allowable.

#### **B5) OTHER SPECIALTY EQUIPMENT**

1. The use of automatic shutter activation devices, such as triggers (photo traps), game cameras, lightning triggers, intervalometers, and laser beam devices are allowed so long as entries do not violate any of the ethical statements or mentioned below in B7 "ETHICS".
2. Drones may be used for capturing images and in the Video category. however Texas law generally prohibits the use of drone-mounted cameras as a means of capturing wildlife photographs, and drone video or images of wildlife are not permitted for entry in this contest.
3. Failure to comply with FAA, Texas Parks and Wildlife, and contest rules regarding drone operation will result in disqualification of submitted images and possible disqualification from the contest per review of the rules committee.
4. Depending upon the status of the drone photographers' operational licensing, drone photographs or videos may not be eligible for monetary reward; however, the placement of the image will be considered in calculating overall contest standing.

#### **B6) DIVISIONS AND CATEGORY SUBMISSIONS**

Images and Video are to be labeled and submitted within specific categories. The categories are organized into Divisions. See ATTACHMENT B for a list of the Divisions and Categories. These Categories do not necessarily represent biological classifications; instead, they are a balance of biological and geographical appearances. Submissions per Category: A maximum of 3 images can be entered per category.

## **B7) ETHICS**

The priority of the contest is conservation of wildlife and its critical habitat. Contestants must minimize disturbance of wildlife and habitat. The welfare of the subject is the foremost consideration. No photographs of tame/domesticated or caged animals will be allowed. No bird nests or mammal or reptile dens may be photographed. No animal may be transported from outside the registered property to be photographed on that property during the contest period, even if it might be found in the wild on that property. Photographs of animals that appear to be overly stressed due to image or video capture activities or appear in situations or habitats extremely uncharacteristic of the animal's typical behavior such that it appears they subject was manipulated will be disqualified.

## **B8) SUBJECT MATTER**

All images must be composed of wildlife, flora, and habitat found on the Registered Land of the Landowner member of each Partnership. Photographs determined to be taken from land other than Registered Land of the Landowner member of each Partnership will be disqualified and may disqualify the photographer and team entirely. The primary wildlife subject in images must be alive and unconstrained. Any vegetation used as a prop must be naturally occurring both in the county (counties) of the Registered Land and on the Registered Land. This may include invasive exotic plants, plants commercially grown on-site, but not ornamental plants found on-site or brought to site. Native plants may be given preferential evaluation in judging.

## **SECTION 3C) EDITING & PROCESSING PHOTOGRAPHS (ALLOWABLE DIGITAL ADJUSTMENTS)**

### **C1) ADDING AND SUBTRACTING FROM AN IMAGE**

All photos must accurately reflect the subject and background as it appeared in the viewfinder. Nothing can be added to an image aside from the elimination of dust spots from a dirty sensor, correction of lens vignetting, and allowable cropping.

### **C2) CROPPING**

Cropping is allowable; however, crops must use one of the 6 aspect ratios listed here: 9x16, 2x3, 5x7, 4x5, 11x14, 1x1. Images are then generated from the cropped TIFF file.

### **C3) TONAL AND COLOR ADJUSTMENTS**

Photographers may only make global image tonal and color corrections at their discretion in submitted images. Examples include brightness, contrast, saturation, hue, shadow, highlights, and other such adjustments. Complete color change of elements within the image is not allowed. For example, changing the color of a flower from blue to violet or from orange to red is not allowed.

### **C4) BACKGROUND BLURRING**

Except for specific categories in the Division SPECIAL, blurring of the background during processing is not allowed. For example, masking a portion of the photo and applying a blur effect or using a blurring brush is NOT allowable. Blurring of the background by selecting the correct aperture size, distance to the subject, and focal length of the lens is a skill that can be used by photographers to blur the background during the shooting of the image rather than the processing stage.

### **C5) SHARPENING**

Moderate sharpening of is allowed at the photographer's discretion when creating JPGs. DO NOT sharpen TIFF images. The publisher will apply appropriate sharpening to the TIFF images for printing purposes. The photo manipulation philosophy should be the same as the "getting a haircut philosophy" ...the idea is to look like you do not need a haircut, NOT like you just got one.

### **C6) REMOVAL OF IMAGE "NOISE"**

Use of denoising software is allowed on either TIFF or JPG images. However, denoising can result in significant degradation of image quality and results should be reviewed before submitting.

## **C7) EXCEPTIONS**

Image Stitching, HDR, and Focus Stacking are only allowed for specific categories within the SPECIAL DIVISION "E".

### **IMPORTANT NOTE:**

The WIF staff, designated volunteers, and/or judges may compare the Photographer's final submissions to their 'RAW' format digital images to verify compliance with the rules including that only allowable manipulations occurred. Any unallowable manipulation will result in that image being disqualified.

## **SECTION 4D) SUBMITTING ENTRIES**

### **D1) IMAGE SUBMISSION DEADLINE**

Image portfolio contest entries may be submitted beginning **June 1, 2025, but must be received no later than 5:00 PM, June 30, 2025.**

Entries should be submitted on one Flash Drive or by online upload via E-Folder. Email submissions will not be accepted. Flash Drives will not be returned. Entries not received by the deadline will not be accepted. WIF does reserve the right to extend the deadline at its discretion.

WIF takes reasonable precautions to protect the images submitted for judging. If any of the flash drives are received damaged, the Photographer will be notified immediately.

WIF urges Photographers to ensure that their images are viewable, and all files are capable of opening on a computer that is not the Photographer's primary computer.

If the WIF Staff, designated volunteers, and/or judges are unable to open any files (JPG, TIFF or Raw) the submitted image will be ruled defective and disqualified, and the photographer notified. If this were to occur, the Photographer may appeal this decision to the Rules Committee and request to cure the defective image but not replace it if judging has commenced.

## **D2) THE THREE FILE TYPES FOR EACH ENTRY**

Each entry will consist of the original RAW file, an optimized TIFF file, and a JPG file. The JPG will be used for judging purposes.

- **RAW Files:** Your RAW file will be the original image that your camera captured at the time the photograph was taken. Your entry RAW files may be optimized with the photographer's software and can be renamed as noted below under paragraph D: "Naming Files", before converting to a TIFF file.
- **TIFF Files:** Your TIFF files will be converted/created from your renamed RAW files and will now have a file extension of ".tif." TIFF images must be submitted using specific requirements.
- **JPG Files:** Your files will be converted from your optimized TIFF file and will now have an extension of ".jpg." files should be submitted with specific settings.

## **D2) NAMING FILES**

Each photographer will be assigned a random 3-digit identification code which they will need to include in their file names to avoid any possible duplicate files. Your files should be labeled as follows:

- RAW: A01-1-000.CR2
- TIFF: A01-1-000.tif
- JPF: A01-1-000.jpg

## **D3) CATEGORIES**

Divisions and Categories are shown in ATTACHMENT B. The decision of which division/category a photograph is entered is the sole discretion and responsibility of the photographer. If an image is known to include an officially endangered species, the Photographer must notify the Landowner.

## **D4) SIMILAR IMAGES**

Photographers may enter only one of a group of VERY similar images. If the same subject is taken with a telephoto lens for a portrait and then a wide-angle lens to show the subject in the environment, it is NOT essentially the same image and can be submitted.

## **D5) MODEL RELEASE FORM**

A signed Model Release Form will be required from each person that can be identified in any image.

## **D6) SUBMISSION PACKAGE**

A submission package may be submitted in person, by mail or digitally (If a digital submission system is available, check with Wildlife In Focus before submission). A physical submission package must be submitted (mailed or hand-delivered) in a 9 X12 or larger envelope to the Wildlife in Focus offices. A copy of the JPG version of the submitted portfolio of images shall be provided to the landowner teammate on a USB Portable Drive, or SD Card, or similar digital memory device. The landowner may only use the images for personal viewing. Permission for any other uses must be obtained from the photographer.

## **D7) PUBLIC SHOWING OF ENTRIES**

Images that have been entered into the contest MUST be withheld from public showing (particularly social media) until AFTER the Photo Premier and Awards Banquet (usually in October).

# **SECTION 5E) GENERAL INFORMATION**

## **E1) JUDGES and JUDGING**

An independent team of judges will judge eligible images based on photographic merit, considering aesthetics, composition, originality, and overall artistic merit. Judges will collectively discuss and choose winning images. Decisions of the judges are final.

## **E2) OWNERSHIP and USE OF IMAGES**

Images remain the property of the Photographer, but WIF retains the rights to use all submitted images indefinitely for WIF purposes, including but not limited to production of brochures, advertising promotions, education, exhibits, and social media. WIF will provide photographer credit as feasible. WIF also reserves the right to market and sell books and merchandise that include submitted images. The net proceeds from print sales will be split 50%/50% between Wildlife in Focus and the Photographer. Images must be withheld from public display, including social media, until after the Awards Banquet.

## **E3) DISPUTE RESOLUTION**

Any controversy or claim arising out of or relating to participation in the contest shall be settled by arbitration, administered by the American Arbitration Association. By entering the contest, entrants agree to arbitration and waive rights to litigation for damages other than actual expenses.

## **E4) GOVERNING LAW**

The Contest is governed by the laws of the State of Texas, with any dispute resolution or litigation to be held in Bexar County, Texas.

## **E5) TAXES AND FEES**

Winners are responsible for all taxes and fees associated with prizes. Entrants will pay their own federal income taxes, and winning participants will be required to fill out a W-9 form to receive prize money.

## **E6) LAWS**

The Contest is subject to all federal, state, and municipal laws and regulations, and the rules are subject to change without notice to comply with applicable laws.

## **E7) TERMINATION**

WIF reserves the right to amend or terminate all or any portion of the Contest at any time for any reason without prior notice.

**IMPORTANT NOTE:** Rules are subject to modification by WIF, including prize amounts and wildlife categories. Participants should verify the latest rules with the WIF office before commencing photography. Thank you for your participation in the 2025 Contest!

Categories were created to represent the entire state of Texas and to attempt to do what is possible to make the overall contest as fair and competitive as possible. Not all sites will have wildlife for each category and the format allows a full portfolio submission even if entering only 34 categories (i.e. not entering in all 50 categories is acceptable. Portfolio can still include 100 images, up to 3 per category entered.)

**Photographer:** Photographers may submit a Portfolio of up to 100 total photos from up to 50 categories. Individual photographers may enter at multiple levels each with specific number of allowed entries, (See details on photographer entries and registration form.)

E02 \*Sunrise/Sunset Rainbows Clouds, Rain scene, Thunderstorms,

E03 Camouflage/Mimicry of wildlife including insects.

E04 \*Patterns in nature

E05 Underwater – Aquatic animals, fish, amphibians, insects, etc.

E06 \*Native Wildflowers or Plants – non-flowers (can include flower but not as the main object of image)

E07 \*Night Scene Photography (non-wildlife) Stars, moon, landscape, light painting

E08 Full Frame - Wildlife Photos in this category may not be cropped at all and must fully represent the complete RAW image as captured.

E09 \*Land Operations - This category is meant to capture realistic farm, ranch revenue operations, habitat conservation, and wildlife/habitat monitoring and research activities which may or may not include livestock and/or people. A signed model release form (Attachment E) is required from each person identifiable in the photographs.

E10 \*Graphic Art – All editing allowed. All images used must be from the contest taken per rules.

E11 Drone Photographs (Note: Wildlife may not appear in this category)

E12 \*Black and White: Monochrome photos only

*Wildlife not required in photographs submitted for (\*) marked categories \**

## ATTACHMENT B – TEAM PHOTO CONTEST PRIZES

The prize money awarded to each team will be divided equally between the winning landowner(s) and photographer(s) of a team, with half of the total prize money going to landowners and the other half to photographers. The final distribution of monetary prizes is subject to change at the discretion of the WIF Board.

**Division Winners:** Division winners are determined based on the accumulated category winnings within each division. A team winner will be determined for each division.

**Grand Prize Winners:** Grand Prize winners are determined based on the total accumulated category winnings. Grand Prize recognition will be awarded to the top 5 teams.

**Total Prize Purse:** The total prize purse for the Team contest is expected to be \$40,000, which includes both the Photo Contest and the Video Contest: \$37,600 for photos, \$2,400 for videos. This purse may be adjusted based on the total sponsorship and funding for the contest prize purse.
